Motion by Farrell Johnson, seconded by Timothy Hill to accept and approve the September 2025 financial report M/C

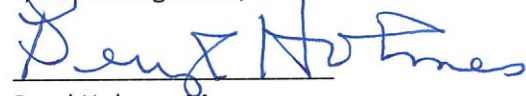
Motion by Farrell Johnson, seconded by Timothy Hill to enter executive session. M/C
