Motion by Shannon Sampson, seconded by Farrell Johnson to approve March 09, 2026, minutes as printed. M/C

Jacob Gauthier of Pan American Engineers updated Mayor Holmes and council of the WWTP Rehabilitation Phase 1 for FY24 LCDBG, LDEQ Clean Water Resolving Fund (CWSRF) Project No. 1 and 2 Inflow/Infiltration Improvements, Sewer pump State Rehabilitation (Water Sector-Phase 2), and on Mayeux Street Sidewalk Rehab (HB 460).

Motion by Shannon Sampson, seconded by Timothy Hill to accept and approve the March 2026 financial report M/C


Motion by Shannon Sampson, seconded by Farrell Johnson to enter executive session. M/C
