The Pump Station Rehab (Water Sector Phase 2) the Village was approved for a grant in the amount of \$1,800,000.00.

The State of Louisiana appropriated \$78,000.00 to the Village of Moreauville for sidewalk. Special thanks to Representative Daryl Deshotel.
