On Monday July 14, 2025, the Mayor and Board of Alderman met in regular session at the Moreauville Town Hall at 6:00 p.m.

Spencer Gauthier of Delta Engineering Group addressed the mayor and council about closing out the Fiscal Year 2022-2023 and Fiscal Year 2023-2024 LGAP grants. Delta Engineering Group is waiting for the contract for the Fiscal Year 2023-2024 and the Fiscal Year 2024-2025 CWEF grant award to replace water mains on Couvillion St. and South Bayou Des Glaisses. Delta Engineering Group is also waiting for approval to incur pre-construction costs for the PHMSA NGDISM gas valve install/replacement project so they can begin the design for the project.

Jacob Gautier of Pan American Engineers informed the mayor and council that Pan American has received authorization from the state to advertise for the WWTP Rehabilitation (CDBG Grant). The project will advertise for bids over the next three (3) weeks, and bids will be received by Pan American Engineers on August 20, 2025.


Motion by Farrell Johnson, seconded by Timothy Hill to accept and approve the June 2025 financial report M/C
